TREADLIGHTLY RECYCLING PROGRAM

More than 110 million shoes are shipped to Australia every year, with a quarter of these being sports footwear.

However, did you know sport shoe components can take up to 1000 years to decompose in landfill?

TreadLightly is a new national recycling program set up by the Australian Sporting Goods Association (ASGA) with recycler Save Our Soles (SOS) to address this problem. The program collects hundreds of tonnes of unwanted training and active lifestyle footwear and recycles them responsibly into new items such as retail and gym flooring and playground components across Australia.

Reuse, then recycle

The first step is to consider whether your pre-loved sports footwear can be reused – sold on, gifted to someone else or donated to charity.

If not, then take them to your local SportsPower, Rebel Sport or The Athletes Foot store for recycling!

- Golf Shoes





During the new Citizenship Ceremony, we welcomed 27 people from 15 countries to our community.

The day finished with a free BBQ lunch, kindly provided by members of the Rotary Clubs of Lismore Networking and Lismore West.



NEW FUNDING For oakes oval **AND CBD UPGRADES**

Council last week received three Federal Government grants totalling \$2,456,340 for three projects that are designed to breathe new life into the CBD and improve community facilities.

- \$430,000 to upgrade Oakes Oval's sports lighting to LED, increasing the brightness to a regional standard and allowing greater use of this facility. It complements the \$12 million upgrade of Crozier and Oakes Ovals that is currently underway.
- \$1,626,340 to renew footpaths surrounding the CBD, on top of the \$1,200,304 announced last year. This will greatly improve the CBD shopping precinct and bring the footpaths up to standard.
- \$400,000 to reconstruct the full length of Bounty Street, including pothole repairs and complete pavement rehabilitation.

Mayor Steve Krieg welcomed the funding announcement which he said would help reinvigorate the CBD and attract more sport tourism to Lismore that would benefit our local businesses and support local jobs.



EAT THE STREET IS BACK FOR 2022

The popular Eat the Street Festival will return to Lismore's CBD on Sunday, 29 May after it was cancelled last year due to COVID-19.

This year's festival was originally scheduled to be held in March, but organisers decided to hold it slightly later in the year to allow our food vendors and suppliers more time to prepare after what has been a turbulent start to 2022, Council's Manager of Liveable and Active Communities Tony Duffy said.

"It's going to be great to be back and we are looking forward to a very successful Eat the Street Festival this year. The activity and excitement it brings to the CBD each year is incredible and this year will be no different".

"It is a great day out for all of the family, and I encourage everyone to come along and enjoy being together as a community once again."

Since its inception in 2016, Eat the Street has guickly become an iconic Northern Rivers festival, showcasing the regions' finest food vendors and entertaining tens of thousands of people.

The 2022 event will consist of a farm tour, live music, cooking demonstrations and live performances.

LISMORE LIGHTS UP FOR SHINE FESTIVAL

After the postponement of the event in 2021, Lismore City Council's SHINE Festival will light up the Lismore CBD from 2 May to 8 May.

SHINE is a discovery focused light festival with sites along Molesworth St and its laneways transformed by contemporary light works that will inspire and ignite the imagination.

Audiences can expect the unexpected as a program of artists present bold new works ranging from small surprises, large scale projections, the telling of untold stories and immersive light installations that will reframe Lismore's CBD.

The free event is made possible by a grant from the Federal Government's Regional Tourism Bushfire Recovery program.

All of the featured artists come from the Northern Rivers, predominately from Lismore.

SHINE is a platform for artists to produce new experimental public works and for local and visiting audiences to experience the high-quality work produced in the region.

WATCH OUT FOR FROGBIT

Frogbit (Limnobium laevigatum), is a fast-growing, aquatic weed that poses a significant threat to our already struggling local waterways.

Forming dense mats, Frogbit threatens native animals by reducing available food and shelter and inhibiting light to native water plants. It can block waterways and irrigation channels and limit recreational activities.

Outbreaks of this invasive water weed are currently occurring around Chinderah, Dorroughby and more recently at Swan Bay. These sites are being actively managed, but we need your help to find others! This weed is listed as **high risk** and is a state and regional target for **Prevention**. It is therefore classified as **PROHIBITED MATTER**.

Frogbit can be identified by its bright green, round fleshy leaves, up to 4cm across. Young leaves float flat on the water surface and have a spongy underside, and as they mature grow above the water surface and lose their sponginess. Flowers are small and white. The fruit is a berry-like capsule that contains up to 100 floating seeds which are easily dispersed, and can remain viable for three years. Frogbit can also spread vegetatively, when fragments attach to animals or water equipment and are transported to new areas.

Do not attempt to treat or dispose of Frogbit yourself. If you see this plant, report it immediately to Rous County Council on (02) 66 233 800. We will lead an initial response for the treatment and disposal of the plant to stop it from spreading.
