EMPLOYMENT LANDS PROJECT UNLOCKS GOONELLABAH INDUSTRIAL ESTATE

The \$14.2 million Employment Lands project in Goonellabah was officially opened last week by Mayor Steve Krieg, State Member for Lismore Janelle Saffin and Federal Member for Page Kevin Hogan.

The project is designed to unlock the Goonellabah Industrial Estate to spur investment and create more local jobs by extending Oliver Avenue to link with the Bruxner Highway at Pineapple Road.

Works included the construction of the Oliver Avenue link, including a new bridge over Tucki Tucki Creek, a new roundabout at the Oliver Ave/Holland St/Taylor Ave intersection, modification/upgrades to the existing roundabout at Bruxner/Holland St to facilitate B-double movements. construction of a new public carpark at Hepburn Park and earthworks to Council-owned land at 260 Oliver Ave to facilitate additional industrial lots.

Mayor Krieg said the project is important for our community as Council looks to attract investment to grow our local economy.

"It's great to see this joint Federal, State and Council funded project now open. It creates more flood-free land for local industry that will create more local jobs," he said.

"The project was delayed due to the February 2022 natural disaster, but I would like to congratulate the construction team on the finished product."

Council secured \$11 million from the New South Wales Government. for the project.

AVOID A FINE AND DECLARE YOUR ASBESTOS LOAD!

There remains a significant number of mixed loads of waste coming into the Lismore Recycling & Recovery Centre containing asbestos materials.

In the last two months since we last reported, we have rejected another 15 loads at our Resource Recovery Facility (aka the big shed) as they were found to contain unbagged asbestos. These usually come from a property clean-out, a DIY renovation job or local builders.

If you are bringing in a load of mixed waste, weighbridge staff will ask you to declare any asbestos. If a load is suspected of containing asbestos, Resource Recovery Facility staff will test it with our microPHAZIR asbestos analyser – a tool that can give an on-the-spot result.

If a load containing asbestos hits the floor in one of the unloading bays, staff must close the bay, suit up, wet down the material, double bag it, take it away for disposal and clean the bay. You will be charged a \$522 clean-up fee to cover these costs, plus disposal of the waste you've brought in.

It's not as expensive as you may think to dispose of asbestos properly.

The Lismore Recycling & Recovery Centre is one of the few waste facilities in the region that accepts asbestos for disposal.

The average household quantity of 100kg of asbestos, or about 10m2, costs about \$55 to properly dispose of (there is a minimum charge of \$20). There is a higher fee for disposing of asbestos if you live outside the Lismore LGA.

Remember we also have Testing Kits FREE of charge and Disposal Kits available for \$30 at Council's **Corporate Centre in Goonellabah and at The Revolve** Shop at the Lismore Recycling & Recovery Centre.

PARKING CHANGES TO SUPPORT OUR LOCAL BUSINESSES

As Lismore continues to recover from the February 2022 natural disaster with more businesses re-opening in the CBD, Lismore City Council will reintroduce paid parking at the Barney Shearman (opposite Dragonfly Cafe) and Rowing Club carparks from Monday, 10 July.

The changes are designed to free up available parking in the heart of the CBD to make it easier for visitors to park, grab a bite to eat or shop at one of many local businesses. Timed parking in the CBD will continue alongside paid parking, further enhancing parking options.

Free untimed parking will remain available for CBD workers and visitors at the John Crowther and Harold Federicks carparks, as well as Lower Hemsley and Heritage Park carparks.

Tradespeople will continue to have access to Council's on-line permit system which allows free parking in the CBD.

In the immediate aftermath of the 2022 disaster, Lismore City Council introduced a range of parking changes to assist in the recovery, including Work Zones for tradies and free parking throughout the CBD.

Over the past six months as the city has moved passed the emergency repair stage, all of the changes have transitioned back to 'standard operations', except for parking at Barney Shearman and Rowing Club carparks.

Over coming months, pay stations at the Barney Shearman and Rowing Club carparks will be further enhanced with the integration of a mobile payment app. This convenient feature will enable users to pay for their parking directly from their smartphones, eliminating the need to walk to the pay station. Information on how to download and use this app will be available on Council's website at www.lismore.nsw.gov.au.

Staff will also be on hand in the morning of the first two days to help commuters use the new system.

As with any significant parking change, during the initial two weeks motorists will be educated about the change rather than receiving a fine.




PROPOSED ROAD LEASE SECTION 154 OF THE ROADS ACT 1993
