### **Background:**

Under Section 356 of the Local Government Act council may, in accordance with a resolution of the council, contribute money or otherwise grant financial assistance to persons for the exercising if its functions. Under Section 377 of the Act, this is one of the functions that council cannot delegate to the general manager. Council's processing of such contributions has been traditionally done in one of three ways:

- An annual budget allocation in the Management Plan as a result of a previous Council decision or adopted policy e.g. annual donations of \$2,000 to Friends of the Koala and \$1,000 to the twenty nine rural halls etc,
- Staff distributing funds upon application in accordance with a Council policy and within the budget allocation e.g. reductions in City Hall rental or representative selection etc,
- Distribution of second hand goods to community groups e.g. computers etc.

A recent review of Council's internal processing of such contributions, together with a management review by the Department of Local Government into the operations of Walgett Shire Council highlighted the need for legal advice on this matter. Whilst I have not received this advice in writing to date, the verbal advice indicates that a specific council resolution is required and that the adoption of the Management Plan is not sufficient.

This will require additional administration in the way we process these donations in the future and may require the revision of some policies. The reason for the urgency of this particular report is that community groups and rural hall committee members have been invited to receive their donations as part of Local Government Week celebrations next week.
